

Certificate in Understanding Safeguarding and Prevent

Although candidates may have completed numerous courses on safeguarding before, this is not a static subject. New threats emerge and better ways of working are developed that help to reduce the likelihood of harm and abuse happening to children and young people. The 'new threats' of our time include cyber-bullying and cyberstalking, as well as online grooming for sexual exploitation. They also include the radicalisation of children and young people by extremists.

Therefore, this important course combines three inter-related themes: safeguarding in general; online safety; and the Prevent duty. The latter places a duty on educational providers and other public bodies to help prevent children, young people and vulnerable adults from being radicalised and drawn into terrorism. This means identifying those at risk and taking the appropriate actions. Those who work with children, young people or vulnerable adults, you have a legal duty in respect of safeguarding and Prevent. This important qualification aims to provide candidates with the practical knowledge they need to be able to comply with this duty.

Who's it for?


This qualification is aimed at anyone who has a responsibility for safeguarding children, young people or vulnerable adults. It will be particularly useful for people working in a training / educational setting, youth workers, and those involved in the running of youth sports teams and community groups that support children and young people.

What are the benefits of doing this course?

As well as attaining a nationally recognised qualification upon completion, candidates will gain a thorough understanding of the Prevent Duty and safeguarding. In terms of Prevent, candidates will explore the key themes of radicalisation, extremism and terrorism, and how to reduce the risk of radicalisation. In the safeguarding unit, they will look at how to recognise signs of abuse or potential harm and know how to respond if abuse or harm is disclosed, suspected or alleged. Finally, in the online safety unit, candidates will examine the potential consequences of inappropriate or illegal online activity, how to reduce the risks posed online, and how to spot signs and behavioural changes that could cause concern.

The course also provides employers with a structured training programme that will meet the training needs of their employees, giving peace of mind that staff are equipped with the knowledge they need to promote the safety and well-being of children, young people and vulnerable adults.
